**Office of Vernon County Clerk
TO THE ELECTORS OF VERNON COUNTY:**

Any qualified elector who is unable or unwilling to appear at the polling place on election day may request to vote an absentee ballot. A qualified elector is any U.S. Citizen, who will be 18 years of age or older on election day, who has resided in the ward or municipality where he or she wishes to vote for at least 10 days before the election.

TO OBTAIN AN ABSENTEE BALLOT, YOU MUST MAKE A REQUEST IN WRITING AND YOU MUST BE A REGISTERED VOTER.

Contact your municipal clerk and request that an application for an absentee ballot be sent to you for the primary or election or both. You may also request an absentee ballot by letter. Your written request must list your voting address within the municipality where you wish to vote, the address where the absentee ballot should be sent, if different, and your signature. If you are not already registered, you will need to also fill out a voter registration application before you will be allowed to vote.

Special absentee voting application provisions apply to electors who are indefinitely confined to home or a care facility, in the military, hospitalized, or serving as a sequestered juror. If this applies to you, contact the municipal clerk for instructions.

You can also personally go the municipal clerk's office or other specified location, complete a written application, and vote an absentee ballot during the hours specified for casting an absentee ballot. For part-time township clerks with offices in their homes and part-time village clerks, it is suggested that you phone in advance to establish a mutually agreeable time to cast the absentee vote.

A listing of municipal clerks in the towns, villages, and cities of Vernon County, on whose behalf this notice is published, follows. Contact the clerk listed for your municipality to secure an absentee ballot. If you are not sure of the municipality in which you reside, contact the County Clerk's Office for assistance.
