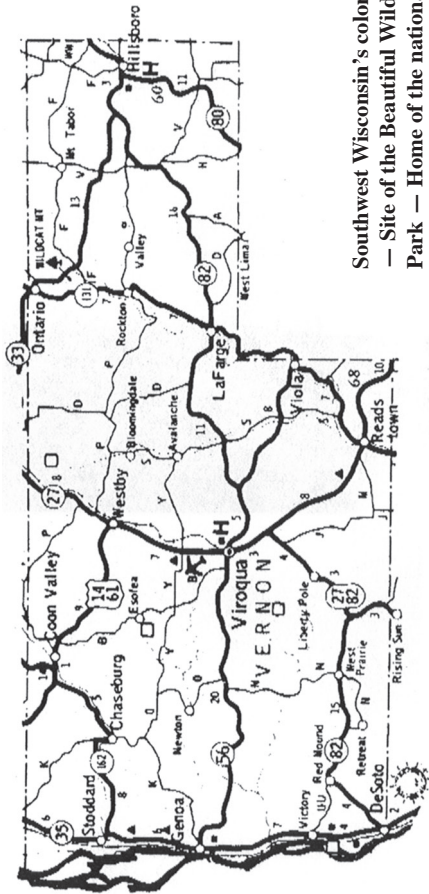
*Floodplain, Shoreland, and Wetland Ordinance

Vernon County has adopted Floodplain, Shoreland, and Wetland Ordinances for unincorporated areas. A Town Building Permit does not exempt a landowner from complying with Vernon County regulations. A county sanitary permit is required for most work (new, replacement, repairs) on septic systems.

Several Towns have adopted some form of Land Use Controls (Ordinances). Please contact the respective Town Clerk.

DO NOT commit funds, sign contracts, or make plans that cannot be changed until you have checked with both the local municipality and the County Zoning & Sanitation Office!
