1. Call to order, JoAnn Nickelatti, Chair, presiding

Hewitt informed the committee he would like to reduce the speed limit on CTH HH because of an intersection that some residents believe is hazardous. In order to reduce the limit by more than 10 mph, a safety study must be done by the D.O.T. Hewitt will contact the D.O.T. to get more information on the process.
