1. Call to order, JoAnn Nickelatti, Chair, presiding

4. Audience to visitors

Mark McFarland, E4028 Upper Newton Road, was present to discuss an issue with the drainage from CTH O and his property. He and the commissioner discussed the history of the drainage and the work done by the county in the past to correct it. The committee agreed that we should try to correct the issue. Hewitt will talk to Corporation Counsel about drafting an agreement to do the work.

5. Jewell Associates – update on projects

Greg Jewell was present to update the committee on the CTH K - HRRRP project and the South Elk Run Road bridge project.

6. Discussion and possible action on bids for salt storage dome

7. Review and approve bridge inspection contract with Jewell Associates Engineers, Inc.

Greg Jewell presented a bridge inspection contract for the 2018-2019 inspection cycle. The contract prices are the same as the previous cycle. Motion by Leis, seconded by Sullivan, to approve the contract. Motion carried.

8. Review and approve new highway shop design contract from Barrientos

9. Discussion and possible action on purchase of self-propelled roller

Hewitt informed the committee he found a used self-propelled roller for \$50,000 from Titan Machinery. There would be an additional \$2500 charge to ship the unit from South Dakota. Motion by Erlandson, seconded by Leis, to purchase the roller from Titan Machinery. Motion carried.

10. Discussion and possible action on ATV route requests

Hewitt presented ATV/UTV route requests from the Town of Franklin, Town of Sterling and City of Hillsboro. See attached. Motion by Leis, seconded by Sullivan, to adopt the requested roads as ATV/UTV routes. Motion carried.

Leis was excused to leave the meeting at this time.

11. Review and approve vouchers for payment

Motion by Erlandson, seconded by Williams, to approve the vouchers. Motion carried.

12. Commissioner's Report – Phil Hewitt – Non-action items

Hewitt updated the committee on the following: The D.O.T. will be using epoxy paint for some of its pavement marking - we are not able to do epoxy paint with our truck; he discussed updating our radios; he updated the committee on the bridge program and said he needs to redo the applications; he will be purchasing a dehumidifier for the Dutch Hollow Shop because of a moisture problem; he talked to personnel and said he received approval to increase the wage for the pavement marking crew leader to the foreman wage grade.
